SOFTWARE LICENCE AGREEMENT

IMPORTANT: All XTAL programs are sold only on the condition that the purchaser agrees to the following licence. **READ THIS LICENCE CAREFULLY.** If you do not agree to the terms contained in this licence, return the packaged discette, **UNOPENED** to your distributor and your purchase price will be refunded. If you agree to the terms contained in this licence, fill out the **REGISTRATION** information and **RETURN** by mail.

CRYSTAL ELECTRONICS (herein after called XTAL) agrees to grant and the customer agrees to accept on the following terms and conditions nontransferable and nonexclusive licences to use the software programs(s) (Licenced Programs) herein delivered with this agreement.

TERM:

This agreement is effective from the date of receipt of the above-referenced program(s) and shall remain in force until terminated by the Customer upon one month's prior written notice, or by XTAL as provided below.

Any licence under this Agreement may be discontinued by the Customer at any time upon one month's notice. XTAL may discontinue any licence or terminate this Agreement if the Customer fails to comply with any of the terms conditions of this Agreement.

LICENCE:

Each programs licence granted under this Agreement authorizes the Customer to use the Licenced Program in any machine readable form on any single computer system (referred to as System). A separate licence is required for each System on which the Licenced Program will be used.

This Agreement and any of the licences, programs or materials to which it applies may not be assigned, sublicenced or otherwise transferred by the Customer without prior written consent from XTAL. No right to print or copy, in whole or in part, the Licenced Programs is granted except as herein after expressly provided.

PERMISSION TO COPY OR MODIFY LICENCED PROGRAMS:

The customer shall not copy, in whole or in part, any Licenced Programs which are provided by XTAL in printed form under this Agreement. Additional copies of printed materials may be acquired from XTAL.

Any Licenced Programs which are provided by XTAL in machine readable form may be copied, in whole or in part, in printed or machine readable form in sufficient number for use by the Customer with designated System, to understand the contents of such machine readable material, to modify the Licenced Program as provided below, for back-up purposes, or for archive purposes, provided, however, that no more than three (3) printed copies will be in existence under any licence at any one time without prior written consent from XTAL. The Customer agrees to maintain appropriate records of the number and location of all such copies of Licenced Programs. The original, and any copies of the Licenced Programs, in whole or in part, which are made by the Customer shall be the property of XTAL. This does not imply, of course, that XTAL owns the media on which the Licenced Programs are recorded. The Customer may modify any machine readable form of the Licenced Programs for his own use and merge it into other program material, to form an update work, provided that, upon discontinuance of the licence for such Licenced Program, the Licenced Program supplied by XTAL will be completely removed from the updated work. Any portion of the Licenced Program included in an update work shall be used only if on the designated System and shall remain subject to all other terms of this Agreement.

The Customer agrees to reproduce and include the copyright notice of XTAL on all copies, in whole or in part, in any form, including partial copies of modifications, of Licenced Programs made hereunder.

PROTECTION AND SECURITY:

The customer agrees not to provide or otherwise make available any Licenced Program including but not limited to program listings, object code, in any form, to any person other than Customer or XTAL employees, without prior written consent from XTAL, except with the Customer's permission for purposes specifically related to the Customer's use of the Licenced Program.

DISCONTINUANCE:

Within one month after the date of discontinuance of any licence under this Agreement, the Customer will furnish XTAL a certificate certifying that through his best effort, and to the best of his knowledge, the original and all copies, in whole or in Part, in any form, including partial copies in modifications, of the Licenced Program received from XTAL or made in connection with such licence have been destroyed, except that, upon prior written authorization from XTAL, the customer may retain a copy for archive purposes.

DISCLAIMER OF WARRANTY:

XTAL makes no warranties with respect to the Licenced Programs. The sole obligations of XTAL shall be to make available all published modifications or updates made by XTAL to licenced Programs which are published within one (1) year from date of purchase, provided Customer has returned the Registration Sheet delivered with the Licenced Program.

LIMITATION OF LIABILITY:

THE FOREGOING WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT WILL XTAL BE LIABLE FOR CONSEQUENTIAL DAMAGES EVEN IF XTAL HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
